**Second Failure of Bidding of LOT A of the project "PURCHASE OF FOOD ITEMS FOR THE IMPLEMENTATION OF SUPPLEMENTAL FEEDING PROGRAM 11TH CYCLE FOR SEVEN (7) PROVINCE OF REGION III"**

**WHEREAS**, the Department of Social Welfare and Development Field Office III (DSWD-FO III) Bids and Awards Committee last July 28, 2021 declared first failure of bidding for the **LOTS A, C and D** of the project "**PURCHASE OF FOOD ITEMS FOR THE IMPLEMENTATION OF SUPPLEMENTAL FEEDING PROGRAM 11TH CYCLE FOR SEVEN (7) PROVINCE OF REGION III**" wherein no bidder actually submitted his/her bid for Lot A and the sole bidder for Lots C and D, namely: **NUTRIDENSE MANUFACTURING FOOD CORPORATION** has been declared failed on the grounds of expired Tax Clearance without its supporting document of on-going renewal;

**WHEREAS**, the DSWD-FO III scheduled the second bidding on September 1, 2021 at 10:00 AM and had advertised the abovementioned project with the following Approved Budget for the Contract (ABC) amounting to:

35.1 The BAC shall declare the bidding a failure when:


- a) No bids are received;
- b) Xxx"




**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:



- b. To resort to Negotiated Procurement as provided in Section 53.1 of the Revised IRR of RA 9184.




