SUBJECT: APPROVAL TO PROCURE EASY-OPEN CANNED TUNA

DATE : 5 OCTOBER 2021

This refers to the request for approval to allow Field Offices to procure requirement for canned tuna in Easy-Open cans. There are Field Offices that have exhausted all efforts to engage with distributors and manufacturers to provide non- easy open tuna flakes in adherence to the standard technical specifications of our FFP components. However, none of them can provide our requirement.

In the exigency of service, due to historically stronger typhoons in the last quarter of the year and Covid-19 pandemic which may further hamper our primary mission to provide Family Food Packs (FFPs), the procurement of non-easy open tuna flakes for the FFPs intended for stockpiling is hereby postponed until further notice. On the other hand, the Field Offices are required to provide a Memorandum to the undersigned the conducted procurement of Easy Open can for our monitoring and information.

Additionally, this option is due to limited availability of required specification and as such be effective until a memo to repeal this guideline is issued.
