BIDS AND AWARDS COMMITTEE (BAC) Resolution No. 2021-11-10

Second Failure of the project "Purchase of Semi-Expendable (ICT Equipment) to be used by various Offices/Programs of DSWD FO III for the 2nd Semester of 2021"

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee last October 13, 2021 declared first failure of bidding of the project "PURCHASE OF SEMI-EXPENDABLE (ICT EQUIPMENT) TO BE USED BY VARIOUS OFFICES/PROGRAMS OF DSWD FO III FOR THE 2ND SEMESTER OF 2021" wherein no bidder actually submitted his/her bid.

WHEREAS, the DSWD-FO III scheduled the second bidding on November 15, 2021 at 9:00 AM and had advertised the abovementioned project with an Approved Budget of the Contract (ABC) amounting to One Million Three Hundred Seventy Thousand Two Hundred Forty Seven Pesos and 86/100 (PhP 1,370,247.86);

Such project having posted the second Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from October 26, 2021 to November 15, 2021;

WHEREAS, on the scheduled Submission and Opening of Bids on November 15, 2021 by 9:00 AM, no prospective bidder signified his/her interest and purchased the bidding document;

WHEREAS, Section 35.1 of 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 explicitly states that:

"Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

b) Xxx"
