FIRST FAILURE FOR THE BIDDING OF THE PROJECT "PURCHASE OF  
OFFICE/CONSUMABLE SUPPLIES FOR THE USE OF VARIOUS  
OFFICES/PROGRAMS FOR NOVEMBER-DECEMBER"

**WHEREAS**, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project **Purchase of Office/Consumable Supplies for the use of various Offices/Programs for November-December 2021** with an Approved Budget for the Contract (ABC) amounting to **Three Million One Hundred Eighty Eight Thousand Nine Hundred Eighty Seven Pesos and 90/100 (PhP3,188,987.90)**, and posted Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from September 24, 2021 to October 13, 2021;


**WHEREAS**, in response to the said advertisements, no prospective bidder signified his/her interest for the said project and purchased the Bidding Document;

**WHEREAS**, no bidder actually submitted any bids on the scheduled Submission and Opening of Bids on October 13, 2021 at 1:30 p.m.;

**WHEREAS**, the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, Section 35 saliently provides that *"The BAC shall declare the bidding a failure when no Bids are received"*;

**WHEREAS**, Section 35.3. provides the subsequent step the BAC should take in case the procurement process is declared a failure, to wit;

*"All bidders who have initially responded to the Invitation to Bid/Request for Expression of Interest and have been declared eligible or short listed in the previous biddings shall be allowed to submit new bids. The BAC shall observe the same process and set the new periods according to the same rules followed during the previous bidding."*

WHEREFORE, the BAC RESOLVES, as it is hereby RESOLVED, to declare the Failure of Bidding for the procurement **PURCHASE OF OFFICE/CONSUMABLE SUPPLIES FOR THE USE OF VARIOUS OFFICES/PROGRAMS FOR NOVEMBER-DECEMBER.** Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or re-posting of the said procurement project upon review of the specifications and other requirements of the project subject for bidding;
