RECOMMENDING THE CANCELLATION OF BIDDING FOR PROCUREMENT OF SERVICE UTILITY VEHICLE FOR THE USE OF DSWD FO III

WHEREAS, the Bids and Awards Committee posted an Invitation to Bid for the Procurement of Service Utility Vehicle for the Use of DSWD Field Office III with an Approved Budget of the Contract in the amount of One Million Five Hundred Thousand Pesos (PHP 1,500,000.00);

WHEREAS, the Department of Budget and Management (DBM) issued Budget Circular No. 2022–1 on February11, 2022 entitled "Omnibus Guidelines on the Acquisition, Use, Rental and Replacement of Government Motor Vehicles" whereby it clearly provides that under Annex "A", for a Head of the Bureau/SG 28 or organization equivalent to a Bureau, Department, Regional Director / SG-28, Department Service Chief / SG 28 or Head of a Bureau Regional Office / SG 26 or organization equivalent to a Bureau Regional Office and other officials of equivalent rank in NGAs, GOCCs and LGUs, the allowable Vehicle Description, Classification and Specifications are as follows:

VEHICLE CLASSIFICATION	VEHICLE DESCRIPTION AND ALLOWED SPECIFICATIONS
Car (Sedan or Hatchback) or	Engine displacement not exceeding 1500 cc for gasoline or diesel; or AFV
MPV	Engine displacement not exceeding 1600 cc for gasoline or 2800 cc for diesel; or AFV

WHEREAS, the Central Office – General Administrative Services Group through the Procurement Management Services (PMS) is scheduled to release a corresponding advisory relative to the guidelines on procurement of motor vehicles which the Bids and Awards Committee now considers possible conflict with the issued authority of the DBM on procurement of a CUV;

WHEREAS, to avoid complication with the parameters set by DBM in the aforementioned Omnibus Guidelines pending issuance of the Central Office of an advisory on acquisition and procurement of motor vehicle, the Bids and Awards Committee deliberated to this effect and resolved to recommend to the Head of the Procuring Entity to exercise her right under Section 41 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, to wit:

Section 41. Reservation Clause

The HoPE reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in the following situations:

XXX...

For any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the GoP, as follows: (i) if the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the HoPE; (ii) if the project is no longer necessary as determined by the HoPE; or (iii) if the source of funds for the project has been withheld or reduced through no fault of the Procuring Entity."

NOW THEREFORE, the BAC RESOLVES, as it is hereby RESOLVED, to recommend to the Head of the Procuring Entity the CANCELLATION OF BIDDING for PROCUREMENT OF SERVICE UTILITY VEHICLE FOR THE USE OF DSWD FO III by virtue of her powers granted under the Reservation Clause (Section 41, of the 2016 Revised IRR of RA 9184).
