WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project **CONSTRUCTION OF TWO-STOREY DSWD FO III FACILITIES UNDER DESIGN AND BUILD SCHEME** with the following Approved Budget for the Contract (ABC) amounting to **Eighteen Million Six Hundred Forty-Five Thousand Pesos (PHP 18,645,00.00)**

WHEREAS, such project was posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III *continuously from April 6, 2022 to April 27, 2022;*

WHEREAS, in response to the said advertisements, only one prospective bidder, namely **E.B MATIAS CONSTRUCTION AND TRADING** signified interest to participate and purchased the Bidding Documents;

WHEREAS, the above-stated prospective bidder, submitted its bid in accordance with the DSWD FO3 Guidelines on Electronic Bid Submission and Receipt within deadline on April 27, 2022 at 9:30 AM;

WHEREAS, at 10:00 AM of the same date, Stage 1 of the Opening of Bids has been conducted at the DSWD RO III – Agency Operations Center (AOC) Building wherein **E.B. MATIAS CONSTRUCTION AND TRADING** submitted his Technical and Financial Documents before the 9:30 AM deadline. The said bidder had his respective representative that virtually attended;

WHEREAS, the Technical documents of the abovementioned bidder was opened wherein the members of the Bids and Awards Committee examined the submitted bid using a non-discretionary "pass/fail" criteria and upon careful review and deliberation, **E.B MATIAS CONSTRUCTION AND TRADING** complied with the eligibility requirements, was declared "**PASSED**";

WHEREAS, in addition to the submitted Technical documents, further evaluation ensued using the criteria found on Annex "M". In collaboration with the Technical Working Group for Infrastructure;

WHEREAS, at Stage 2 conducted on April 29, 2022 at 10:00 AM, the Technical Working Group declared the result of its evaluation, whereby, the bidder, **MATIAS CONSTRUCTION AND TRADING** merited a rating of 90.95 points, declaring the said bidder as "**PASSED**" and eligible to proceed to the Opening of its Financial Proposal.

WHEREAS, the respective Financial Proposal submitted by **E.B MATIAS CONSTRUCTION AND TRADING** was opened accordingly to which the bid amount of **E.B MATIAS CONSTRUCTION AND TRADING** was read and after which, a detailed evaluation
