**Adopting and Confirming the Post Qualification Evaluation Report (PQER) of
TWG and Declaring the Bidder with the Single Calculated and Responsive Bid
(SCRB)**

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee (BAC) held the Pre-Bidding Conference for the project, "**Construction of Two-Storey DSWD FO III Facilities and Building under Design and Build Scheme**" April 12, 2022 and thereafter, conducted the Opening of Bids in accordance with "**Annex G**" of the **2016 IRR RA 9184** on April 27, 2022 for the First Stage, wherein the Bids and Awards Committee proceeded with the opening of the Technical Component of the prospective bidder before the 9:30 AM deadline;

WHEREAS, in response to the said advertisement, **only one (1) prospective bidder, namely E.B. MATIAS CONSTRUCTION AND TRADING, signified its interest to participate and purchased the Bidding Documents;**


WHEREAS, the Technical documents of the abovementioned bidder was opened wherein the members of the Bids and Awards Committee examined the submitted bid using a non-discretionary "**pass/fail**" criteria and upon careful review and deliberation, **E.B MATIAS CONSTRUCTION AND TRADING**, having complied with the eligibility requirements, was declared "**PASSED**";


WHEREAS, on April 29, 2022 at 10:00AM, the Bids and Awards Committee (BAC) convened to conduct the **2nd Stage of the bidding process beginning with the declaration of the result of the evaluation using the criteria set forth in Annex "M"** wherein **E.B. MATIAS CONSTRUCTION AND TRADING** acquired a rating of **90.95** points. Therefore, proclaiming **E.B. MATIAS CONSTRUCTION AND TRADING** as "**PASSED**".

WHEREAS, the BAC upon Opening of the Financial Proposal, rated the submitted Financial Component of **E.B MATIAS CONSTRUCTION AND TRADING** as "**PASSED**"; which led to the conduct of its Post Qualification in order to verify and validate the authenticity and genuineness of all its submitted technical, legal and financial documents, and to ascertain the compliance with the required technical specifications of its actual offer;

WHEREAS, at the Post-Qualification of **E.B MATIAS CONSTRUCTION AND TRADING**, its representative was able to tender and submit all documents necessary to validate its technical, legal and financial capability to handle the procurement project.

If the BAC determines that the bidder with the Single Calculated Bid passes all the criteria for post-qualification, it shall declare the said bidder as the bidder with the Single Calculated Responsive Bid, and the head of the Procuring Entity concerned shall award the contract to the said bidder. (IRR-A Section 34.3) The

- c) To recommend for approval by the Regional Director of the Department of Social Welfare and Development Regional Office III, as the Head of the Procuring Entity, the foregoing findings.


