FIRST FAILURE FOR THE BIDDING OF THE PROJECT "SUPPLY AND DELIVERY OF ONE (1) UNIT CROSSOVER UTILITY VEHICLE FOR DSWD FIELD OFFICE III"

June 21, 2022

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project Supply and Delivery of One (1) Unit Crossover Utility Vehicle for DSWD Field Office III under ITB No. GOP/DSWD3-2022-05-001 with an Approved Budget for the Contract (ABC) amounting to One Million Five Hundred Pesos (PhP1,500,000.00), and posted Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from May 27 to June 21, 2022;

WHEREAS, in response to the said advertisements, no prospective bidder signified his/her interest for the said project and purchased the Bidding Document;

WHEREAS, no bidder actually submitted any bids on the scheduled Submission and Opening of Bids on June 21, 2022 at 9:00 a.m.;

WHEREAS, in the mandatory review to ascertain the reason and factors contributing to the failure, the End User Admin-General Services Section would confirm with the possibility of delivering the unit to City of San Fernando Pampanga within 7 days from the issuance of Notice To Proceed. Moreover, the BAC Secretariat would revise the Single Largest Completed Contract required as stated "Supply and Delivery of any 4-Wheeled Motor Vehicle";

WHEREAS, the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, Section 35 saliently provides that "The BAC shall declare the bidding a failure when no Bids are received";

WHEREAS, Section 35.3, provides the subsequent step the BAC should take in case the procurement process is declared a failure, to wit;

"All bidders who have initially responded to the Invitation to Bid/Request for Expression of Interest and have been declared eligible or short listed in the previous biddings shall be allowed to submit new bids. The BAC shall observe the same process and set the new periods according to the same rules followed during the previous bidding."

WHEREFORE, the BAC RESOLVES, as it is hereby RESOLVED, to declare the First Failure of Bidding for the procurement SUPPLY AND DELIVERY OF ONE (1) UNIT CROSSOVER UTILITY VEHICLE FOR DSWD FIELD OFFICE III. Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or re-posting of the said procurement project upon review of the specifications and other requirements of the project subject for bidding;
