**WHEREAS**, in the mandatory review to ascertain the reason and factors contributing to the failure, the Bids and Awards Committee directed the BAC Secretariat to highlight the eligibility requirements set forth in RA 9184 and the lifting of the mandatory submission of valid and current PhilGEPS Registration Certification and Membership; all eligibility documentary requirements and present a sample on how to accomplish the technical specification at Pre-Bid Conference.

**WHEREFORE**, the BAC RESOLVES, as it is hereby RESOLVED, to declare the First Failure of Bidding for the project “**DELIVERY AND RECHARGING/REFILLING OF FIRE EXTINGUISHER OF DSWD FO III, DSWD PROVINCIAL EXTENSION OFFICE AND CENTERS AND INSTITUTIONS**”.
