**Adopting and Confirming the Post Qualification Evaluation Report (PQER) of
TWG and Declaring the Bidder with the Lowest Calculated and Responsive Bid
(LCRB)**

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project **PURCHASE OF NEW VARIOUS SEMI-EXPENDABLE ICT EQUIPMENT FOR FIELD OFFICE III** with the Approved Budget for the Contract (ABC) amounting to: **PHP 2,826,091.40**

WHEREAS, the Bids and Awards Committee conducted the Opening of Bids on May 4, 2022 with prospective bidders, namely **LHANZ CJ TRADING AND COMPUTER CENTER INC** and **PRONET SYSTEMS INTEGRATED NETWORKS SOLUTIONS INC.** signifying their interest to participate and purchased the Bidding Document;

WHEREAS, on the same date, the Technical documents of the abovementioned bidder were opened wherein the members of the Bids and Awards Committee examined the submitted bid using the non-discretionary "pass/fail" criteria. Upon careful review and deliberation, **LHANZ CJ TRADING AND COMPUTER CENTER INC** was declared as "**FAILED**" due to no Signature of Bidder or Authorized Representative in the Technical Specifications and **PRONET SYSTEMS INTEGRATED NETWORKS SOLUTIONS INC.**, having complied with the eligibility requirements, was declared "**PASSED**";

WHEREAS, the BAC upon Opening of the Financial Proposal, rated the submitted Financial Component of **PRONET SYSTEMS INTEGRATED NETWORKS SOLUTIONS INC.** as "**Lowest Calculated Bid**"; which led to the conduct of its Post Qualification in order to verify and validate the authenticity and genuineness of all its submitted technical, legal and financial documents, and to ascertain the compliance with the required technical specifications of its actual offer;

WHEREAS, having no issues on the submitted bid and acquiring a "**PASSED**" recommendation from the Technical Working Group for ICT Equipment, the BAC and TWG proceeded to the conduct of Post Qualification of **PRONET SYSTEMS INTEGRATED NETWORKS SOLUTIONS INC.** in order to verify and validate the authenticity and genuineness of all its submitted technical, legal and financial documents, and to ascertain the compliance with the required technical specifications of its actual offer;

WHEREAS, the Post Qualification Evaluation Report of the TWG for **PRONET SYSTEMS INTEGRATED NETWORKS SOLUTIONS INC.** yields a positive result indicating that the latter is "**responsive**" to the bidding policies and requirements;

NOW, WHEREFORE, on the basis of the foregoing, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, that the Bids and Awards Committee resort:
