**Adopting and Confirming the Detailed Bid Evaluation Report (DBER) of TWG
and Declaring the Bidder with the Lowest Calculated Bid (LCB)**

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project **Procurement of PPE Items of DSWD FO III in response to the COVID-19 Pandemic** with the Approved Budget for the Contract (ABC) amounting to: **One Million Six Hundred Sixty Thousand Three Hundred Sixty-Two and 45/100 Pesos (PHP 1,660,362.45);**

WHEREAS, such project was posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from June 18, 2022 to July 11, 2022;

WHEREAS, in response to the said advertisements, **KRIZLANS PHARMACY & TRADING, PAMPANGA HOSPITAL PRODUCT, PHILIPPINES VISION GROUP INC., CRED GENERAL TRADING and PRE-ANS ENTERPRISES** signified their intent to participate and purchased Bidding Documents for;

WHEREAS, the above-stated prospective bidders submitted their bids in accordance with the DSWD FO3 Guidelines on Electronic Bid Submission and Receipt within deadline on July 11, 2022 at 12:00 NN;

WHEREAS, at 1:30 PM of the same date, the Opening of Bids was conducted at ARDO's Office 2nd Floor Main Building of DSWD FO III; and the participating bidders had their representatives virtually attend the said Opening of Bids;

WHEREAS, on the same date, the Technical documents of the abovementioned bidders were opened wherein the members of the Bids and Awards Committee examined the submitted bid using a non-discretionary "pass/fail" criteria and upon careful review and deliberation, **KRIZLANS PHARMACY & TRADING, PHILIPPINES VISION GROUP INC. and CRED GENERAL TRADING** complied with the eligibility requirements, was declared "PASSED"; herein summarized as follows:


