### Adopting and Confirming the Post Qualification Evaluation Report (PQER) of TWG and Declaring the Bidder with the Lowest Calculated and Responsive Bid (LCRB)

**WHEREAS**, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project **PURCHASE OF PRE-PACKED PPE KITS FOR THE USE OF DSWD FO III RESPONSE TO THE COVID-19 PANDEMIC** with the Approved Budget for the Contract (ABC) amounting to: **PHP 1,660,362.45**

**WHEREAS**, the Bids and Awards Committee conducted the Opening of Bids on July 11, 2022 with prospective bidders, namely **PAMPANGA HOSPITAL PRODUCT, KRIZLANS PHARMACY AND TRADING, PRE-ANS ENTERPRISES, CRED GENERAL TRADING** and **PHILIPPINE VISION GROUP INC.**, signifying their interest to participate and purchased the Bidding Document;

**WHEREAS**, on the same date, the Technical documents of the abovementioned bidder were opened wherein the members of the Bids and Awards Committee examined the submitted bid using the non-discretionary "pass/fail" criteria. Upon careful review and deliberation, **PAMPANGA HOSPITAL PRODUCT** and **PRE-ANS ENTERPRISES** were declared as "**FAILED**" due to non-submission of current and updated PhilGEPS Platinum Registration and Membership, No supporting documents in the Statement of All On-going and failure to indicate the corresponding individual performance parameter for bid offered either in the Statement of compliance or evidence presented. Thus, **KRIZLANS PHARMACY AND TRADING, CRED GENERAL TRADING** and **PHILIPPINE VISION GROUP INC.**, having complied with the eligibility requirements, were declared "**PASSED**";

**WHEREAS**, the BAC upon Opening of the Financial Proposal, rated the submitted Financial Component of **CRED GENERAL TRADING** as "**Lowest Calculated Bid**"; which led to the conduct of its Post Qualification in order to verify and validate the authenticity and genuineness of all its submitted technical, legal and financial documents, and to ascertain the compliance with the required technical specifications of its actual offer;


**WHEREAS**, having no issues on the submitted bid and acquiring a "**PASSED**" recommendation from the Technical Working Group for PPE's, the BAC and TWG proceeded to the conduct of Post Qualification of **CRED GENERAL TRADING** in order to verify and validate the authenticity and genuineness of all its submitted technical, legal and financial documents, and to ascertain the compliance with the required technical specifications of its actual offer;

**WHEREAS**, the Post Qualification Evaluation Report of the TWG for **CRED GENERAL TRADING** yields a positive result indicating that the latter is "**responsive**" to the bidding policies and requirements;


- a) To adopt and confirm the Post Qualification Evaluation Report (PQER) submitted by the BAC Technical Working Group for PPE's;
