WHEREAS, Section 7.1, Rule II of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act. (RA) No. 9184, otherwise known as the Government Procurement Reform Act (GPRA), states that "All procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity. Consistent with government fiscal discipline measures, only those considered crucial to the efficient discharge of governmental functions shall be included in the Annual Procurement Plan (APP);

WHEREAS, Section 5.0 Agency Accountabilities of Memorandum Circular No. 2022 – 01 also known as "Guidelines on the Performance Based Bonus (PBB) for Fiscal Year 2022 under Executive Order No. 80, Series of 2012 and Executive Order No. 201, Series of 2016 requires all Procuring Entities compliance to the "Posting of Indicative FY 2023 APP – Non CSE" reiterated in ANNEX "6" of Memorandum Circular No. 2022-01 issued by the "INTER-AGENCY TASK FORCE ON THE HARMONIZATION OF NATIONAL GOVERNMENT PERFORMANCE MONITORING, INFORMATION AND REPORTING SYSTEM"
