**Adopting and Confirming the Detailed Bid Evaluation Report (DBER) of TWG
and Declaring the Bidder with the Lowest Calculated Bid (LCB)**

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project **“SUPPLY AND DELIVERY OF HYGIENE KITS FOR STOCKPILING AND PREPOSITIONING”** with the Approved Budget for the Contract (ABC) amounting to: **Three Million Three Hundred Thousand Pesos (PHP 3,300,000.00)**;

WHEREAS, such project was posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from August 20, 2022 to September 12, 2022;

WHEREAS, in response to the said advertisements, **L. VICTORIA TRADING, VITA MAX PRIMETRADING INC., ANCLAZE TRADING CORPORATION, ANJENE INDUSTRIES INC. and BLUEMOUNTAIN SAFETY AND INDUSTRIAL** manifested their intent to participate in the bidding, however **BLUEMOUNTAIN SAFETY AND INDUSTRIAL** did not submit its bid;

WHEREAS, the above-stated prospective bidders submitted their bids in accordance with the DSWD FO3 Guidelines on Electronic Bid Submission and Receipt within deadline on September 12, 2022 at 9:30 AM;

WHEREAS, at 10:00 AM of the same date, the Opening of Bids was conducted at ARDO's Office 2nd Floor Main Building of DSWD FO III in the presence of the following BAC members: Priscila C. Tiopengco; Provisional BAC member Clenson B. Tibangay; Provsional BAC memeber Sheila Jaen Basilla, presided by the Vie Chairperson Renann M. Macapinlac; and the participating bidders had their representatives virtually attend the said Opening of Bids;

WHEREAS, on the same date, the Technical documents of the abovementioned bidders were opened wherein the members of the Bids and Awards Committee examined the submitted bid using a non-discretionary “pass/fail” criteria and upon careful review and deliberation, **VITA MAX PRIMETRADING INC., ANCLAZE TRADING CORPORATION, ANJENE INDUSTRIES INC.** were declared **“FAILED”**; however, **L. VICTORIA TRADING** was declared as **“PASSED”**, summarized as follows:
