WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project: *Negotiated Procurement of Two-Failed Bidding "PURCHASE OF 3RD QUARTER OFFICE/CONSUMABLE SUPPLIES FOR THE USE OF OFFICES/PROGRAMS CY 2022"* for three (3) separate lots with the following Approved Budget for the Contract (ABC) amounting to:

WHEREAS, such project was posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from August 11 to August 30, 2022;

WHEREAS, at 10:00 AM of the same date, the Opening of Bids was conducted at DSWD RO III – Regional Directors Conference Room; and the participating bidders elected their representatives to virtually attend the Opening of Bids;

WHEREAS, on the same date, the Technical documents of the abovementioned bidders were opened wherein the members of the Bids and Awards Committee examined the submitted bids using a non-discretionary “pass/fail” criteria and upon careful review and deliberation, **G-WELL GENERAL MERCHANDISE** and **MB PELAEZ SCHOOL AND OFFICE SUPPLIES** complied with the eligibility requirements and thus were declared “PASSED” for LOT A;

WHEREAS, in the matter of LOT B, **G-WELL GENERAL MERCHANDISE**, **MB PELAEZ SCHOOL AND OFFICE SUPPLIES** and **MTC ADS AND GENERAL MERCHANDISE** complied with the eligibility requirements and thus, were declared “PASSED”; However **VMT ENTERPRISE** was declared “FAILED” due to failure to submit a current and updated PhilGEPS Platinum Registration and Membership.

WHEREAS, relative to LOT C, **MTC ADS AND GENERAL MERCHANDISE** complied with the eligibility requirements, was declared “PASSED”; On the other hand, **OFFICE EDGE ENTERPRISE** was declared “FAILED” due to failure to support evidence for its offer/bid (*i.e. the evidence submitted was for D203E instead of D203L*); and non-submission of documents re Manpower, Aftersales and Delivery Schedule.





- c) To declare a **FIRST FAILURE OF BIDDING** for the **PURCHASE OF 3RD QUARTER OFFICE/CONSUMABLE SUPPLIES FOR THE USE OF OFFICES/PROGRAMS CY 2022 – LOT C** in accordance with Section 35.1 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184; and


