Job responsibilities of Inspector

The Inspector shall conduct regular audit, inspection and perform job evaluation as reference of the service provider on weekly basis, to ensure quality work performance of twenty-six (26) personnel inclusive of the supervisor. The assigned inspector coordinates his/her activities with the Office of the General Services Section Chief or his/her representative from General Services Section.

The weekly garbage bags quantity requirement is forecasted in strict implementation of garbage segregation and 7s of Good Housekeeping.
