### SINGLE LARGEST COMPLETED CONTRACT

For this purpose, contracts similar to the Project refer to contracts which have the same major categories of work, which shall be: For this purpose, contracts similar to the Project refer to contracts which have the same major categories of work, which shall be:

Contractor shall have a Single Largest Completed Contract with similar project contract and scope such as concrete vertical two-storey and construction of Building with Architectural, Electrical, Mechanical, Sanitary works and concrete pavement works involving components: design component (architectural/engineering aspect of the project) and construction component (infrastructure aspect of the project) within ten (10) years from the deadline of bid submission, whose value of contract amount must be at least fifty percent (50%) of the ABC supported by the Contractors Performance Evaluation System rating or a certificate of satisfactory rating or certificate of

The prospective bidder must have completed an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. Provided, however, that contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB.

Thus, the SLCC requirement shall apply as follows:



satisfactory completion of the project issued by the owner of the previous completed project.

In the event that the bidder does not have a similar largest completed contract for design and build, it should submit at least one (1) similar contract for design, which should be at least fifty percent (50%) of the ABC for the project and at least one (1) contract for construction, each of which should be at least fifty percent (50%) of the cost of the ABC

SPECIAL CONDITIONS OF THE CONTRACT					
Liquidated Damages	In accordance with Section 68 of the 2016 Revised IRR of Republic Act No. 9184, liquidated damages which shall be payable by the contractor in case of breach thereof shall be as follows:				
	For the procurement of Goods, Infrastructure Projects and Consulting Services, the amount of the liquidated damages shall be at least equal to one-tenth of one percent (0.001) of the cost of the unperformed portion for every day of delay.				
	Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.				
Compliance to Data Privacy Act of 2012	Non-compliance by the bidder and its implementation partner/s with the provisions of Republic Act No. 10173, known as the "Data Privacy Act of 2012" and its Implementing Rules and Regulations is also considered as "Unlawful Act".				
Other Requirements	The bidder must be of good standing and has at least satisfactory performance with respect to its ongoing and latest completed project with DSWD (Central Office and Field Offices.)  (Note: This is applicable only to the prospective bidder with previous project/s or contract/s with DSWD which was/were: (i) awarded through Public Bidding, Limited Source Bidding or Negotiated Procurement-Two Failed Biddings; and (ii)entered into within the past three (3) years prior to the date of bid submission. 	evaluation/verification purposes, the eligible bidder may be asked to provide additional information regarding its statement prior or during the post- qualification.

Submission of ITR and Audited Financial Documents	A copy of the latest ITR and Audited Financial Documents (in comparative or separate form) shall be presented at Post Qualification.		
Submission of Schedule of Requirements	A duly signed Schedule of Requirements must be submitted and included in the Technical Folder at Opening of Bids.		

Pursuant to the Revised Implementing Rules and Regulations of RA 9184, the foregoing **amendments** shall form an integral part of the project's Bidding Documents and related Contract. Further, acknowledgment and receipt of this supplemental bid bulletin shall bound the bidder/s of the terms and conditions set forth, otherwise, the nonconformity thereof may consider the bid as nonresponsive to the bidding policies. Consequently, the same may result in the disqualification and/or rejection of the concerned bidder's Bid.

In any instance, receipt of this Supplemental Bid bulletin by the bidders presupposed that in the course of the preparation of their respective bids, they have understood and complied with the amended specifications and terms expressed herein.

Any provision inconsistent herewith is hereby amended and superseded accordingly.

This Bid Bulletin shall form part of the bidding documents.
