## BIDS AND AWARDS COMMITTEE (BAC) Resolution No. 2022-04-01

FIRST FAILURE FOR THE BIDDING OF THE PROJECT "CONSTRUCTION OF TWO – STOREY DSWD FO III BUILDING AND FACILITIES UNDER DESIGN AND BUILD SCHEME"

April 5, 2022

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project Construction of Two – Storey DSWD FO III Building and Facilities under Design and Build Scheme under ITB No. GOP/DSWD3-2022-03-001 with an Approved Budget for the Contract (ABC) amounting to Eighteen Million Six Hundred Forty-Five Thousand Pesos (PhP18,645,000.00), and posted Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from March 16, 2022 to April 5, 2022;

WHEREAS, in response to the said advertisements, no prospective bidder signified his/her interest for the said project and purchased the Bidding Document;

WHEREAS, no bidder actually submitted any bids on the scheduled Submission and Opening of Bids on April 5, 2022 at 9:00 a.m.;

WHEREAS, the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, Section 35 saliently provides that "The BAC shall declare the bidding a failure when no Bids are received";

**WHEREAS**, Section 35.3. provides the subsequent step the BAC should take in case the procurement process is declared a failure, to wit;

"All bidders who have initially responded to the Invitation to Bid/Request for Expression of Interest and have been declared eligible or short listed in the previous biddings shall be allowed to submit new bids. The BAC shall observe the same process and set the new periods according to the same rules followed during the previous bidding."

WHEREAS, in the mandatory review of the terms, conditions and specifications of the project pursuant to Section 35.1 of the same law, the BAC opted to retain the terms of references and manpower count proposed by the End-User with an instruction to the Secretariat to clarify at Pre-Bidding Conference that the designs and plans to be submitted at Opening are merely conceptual in nature. Moreover, invitation to all PhilGEPS contractors within the Region and nearby areas shall be made to increase chances of successful bidding;

**WHEREAS**, it was also decided that submission of bids shall still be done electronically following the Guidelines on eBid Submission and the selected documents which must be sent in hard copies based on Annex "M" – Criteria for Evaluation for additional points may be done via courier or in person;

WHEREFORE, the BAC RESOLVES, as it is hereby RESOLVED, to declare the First Failure of Bidding for the procurement CONSTRUCTION OF TWO – STOREY DSWD FO III BUILDING AND FACILITIES UNDER DESIGN AND BUILD SCHEME. Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or re-posting of the said procurement project upon review of the specifications and other requirements of the project subject for bidding;
