FIRST FAILURE FOR THE BIDDING OF THE PROJECT "PURCHASE OF NEW VARIOUS ICT EQUIPMENT FOR AGENCY OPERATION CENTER (AOC) AND FIELD OFFICE III"

April 13, 2022

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project Purchase of New Various ICT Equipment for Agency Operation Center (AOC) and Field Office III under ITB No. GOP/DSWD3-2022-03-002 with an Approved Budget for the Contract (ABC) amounting to Two Million Nine Hundred Ninety-Five Thousand Two Hundred Twelve Pesos (PhP2,995,212.00), and posted Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from March 22, 2022 to April 12, 2022;

WHEREAS, in response to the said advertisements, no prospective bidder signified his/her interest for the said project and purchased the Bidding Document;

WHEREAS, no bidder actually submitted any bids on the scheduled Submission and Opening of Bids on April 13, 2022 at 9:00 a.m.;

WHEREAS, the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, Section 35 saliently provides that "The BAC shall declare the bidding a failure when no Bids are received":

WHEREAS, Section 35.3. provides the subsequent step the BAC should take in case the procurement process is declared a failure, to wit:

"All bidders who have initially responded to the Invitation to Bid/Request for Expression of Interest and have been declared eligible or short listed in the previous biddings shall be allowed to submit new bids. The BAC shall observe the same process and set the new periods according to the same rules followed during the previous bidding."

WHEREAS, in the mandatory review of the terms, conditions and specifications of the project pursuant to Section 35.1 of the same law, the BAC opted to amend the additional requirements which now shall read as follows:

"To protect DSWD from unreliable and unproven products, ANY proof of evidence (e.g. website page, picture, downloadable brochure and the like) of the following is required:

- 1. Manufacturer of the proposed brand should be ISO 9001:2015 certified or better;
- 2. Proposed BRAND should be Energy Star Compliant;
- 3. Proposed BRAND should have an existing technical web support; and
- 4. Manufacturer's Proposed Brand must be capable of supporting Nationwide deployment with accredited Service Centers within Central Luzon and/or NCR."

WHEREFORE, the BAC RESOLVES, as it is hereby RESOLVED, to declare the First Failure of Bidding for the procurement PURCHASE OF NEW VARIOUS ICT EQUIPMENT FOR AGENCY OPERATION CENTER (AOC) AND FIELD OFFICE III. Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or re-posting of the said procurement project upon review of the specifications and other requirements of the project subject for bidding;
