WHEREAS, upon careful review and deliberation for Lot I, PHILIPPINE VISION GROUP INC. having complied with the eligibility requirements, was declared "PASSED"; On the other hand, the Bids and Awards Committee found that the documents submitted by the other Service Providers resulted to the following findings:

- 1. Failure to attach evidence such as Literature, Brochure, etc. of all the items
- Non-submission of 2021 Audited Financial Statement
- Non-submission of Price Schedule

WHEREAS, the aforementioned findings constituted the grounds for the "FAILED" rating of the submitted Technical Component Folders of the abovementioned bidders.

WHEREAS, in the matter of Lot II, three (3) prospective bidders namely: G-WELL GENERAL MERCHANDISE, OFFICE EDGE ENTERPRISE and MTC ADS AND GENERAL MERCHANDISE signified their intent to participate. However, after careful review and evaluation, all service providers were rated "FAIL" due to similar
