- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of ONE MILLION FOUR HUNDRED NINETY-FIVE THOUSAND PESOS ONLY (Php 1,495,000.00) or such other sums as may be ascertained, TOYOTA QUEZON AVENUE, INC. agrees to deliver the One (1) Unit Crossover Utility Vehicle in accordance with her/its Bid.
- The DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE III agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
