In consideration for the sum of SIX HUNDRED NINETY-EIGHT THOUSAND SEVEN HUNDRED EIGHTY PESOS ONLY (Php 698,780.00) or such other sums as may be ascertained, MTC ADS GENERAL MERCHANDISE agrees to deliver the 4TH Quarter Office/Consumable Supplies for the Use of Offices/Programs CY 2022- Lot B in accordance with her/its Bid.
- The DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE III agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
