

Contract of Agreement No. 2022-11-62

PURCHASE OF 3rd QUARTER OFFICE/CONSUMABLE SUPPLIES FOR THE USE OF OFFICES/PROGRAMS CY 2022 - LOT C

This agreement made this ___ day of DEC 07 2022 2022 between

DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE III, a national government agency operating under the laws of the Republic of the Philippines, with office address at Diosdado Macapagal Regional Government Center, Barangay Maimpis, City of San Fernando, Pampanga represented by its Regional Director, **JONATHAN V. DIRAIN**, hereinafter referred to as the **"PROCURING ENTITY"**;

- AND -

MTC ADS AND GENERAL MERCHANDISE a company duly registered under DTI No. 2469356 with office address at Unit 1-C, CT Centra Bldg., Sindalan, City of San Fernando Pampanga represented by **MADONNA T. CATA CUTAN** in her capacity as Owner, hereinafter referred to as the **"SUPPLIER"**; (collectively, the "Parties").

WHEREAS, the **"PROCURING ENTITY"** invited Bids for certain goods, viz., **PURCHASE OF 3rd QUARTER OFFICE/CONSUMABLE SUPPLIES FOR THE USE OF OFFICES/PROGRAMS CY 2022 – LOT C** and has accepted a Bid by the Supplier for the supply of those goods in the sum of **ONE MILLION SIX HUNDRED SEVENTY-SIX THOUSAND SIX HUNDRED EIGHTY-FIVE PESOS ONLY (Php 1,676,685.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical

and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **ONE MILLION SIX HUNDRED SEVENTY-SIX THOUSAND SIX HUNDRED EIGHTY-FIVE PESOS ONLY (Php 1,676,685.00)** or such other sums as may be ascertained, **MTC ADS GENERAL MERCHANDISE** agrees to deliver the **3RD Quarter Office/Consumable Supplies for the Use of Offices/Programs CY 2022- Lot C** in accordance with her/its Bid.
4. The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE III** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
