

## Contract of Agreement No. 2022-11-60

### SUPPLY AND DELIVERY OF DIGITAL COLOR LASER COPIER PRINTER SCANNER MACHINE FOR DSWD FIELD OFFICE III AND DSWD PROVINCIAL EXTENSION OFFICES

This agreement made this \_\_\_ day of DEC 07 2022 2022 between

**DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE III**, a national government agency operating under the laws of the Republic of the Philippines, with office address at Diosdado Macapagal Regional Government Center, Barangay Maimpis, City of San Fernando, Pampanga represented by its Regional Director, **JONATHAN V. DIRAIN**, hereinafter referred to as the "**PROCURING ENTITY**";

- AND -

**LINK NETWORK SOLUTIONS INC.** a company duly registered under SEC No. CS200804606 with office address at 2<sup>nd</sup> Floor, Matheus Bldg. General Luna St., Poblacion Makati City, Metro Manila, NCR, Philippines represented by **MS. JANINE LIZABETH M. CONCEPCION** in her capacity as Authorized Representative, hereinafter referred to as the "**SUPPLIER**"; (collectively, the "Parties").

**WHEREAS**, the "**PROCURING ENTITY**" invited Bids for certain goods, viz., **SUPPLY AND DELIVERY OF DIGITAL COLOR LASER COPIER PRINTER SCANNER MACHINE FOR DSWD FIELD OFFICE III AND DSWD PROVINCIAL EXTENSION OFFICES** and has accepted a Bid by the Supplier for the supply of those goods in the sum of **SIX HUNDRED THIRTY-SIX THOUSAND PESOS ONLY (Php 636,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Request for Quotation;
    - i. Schedule of Requirements;
    - ii. Technical Specifications; and
    - iii. TWG Assessment Report.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - iii. Warranty Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **SIX HUNDRED THIRTY-SIX THOUSAND PESOS ONLY (Php 636,000.00)** or such other sums as may be ascertained, **LINK NETWORK SOLUTIONS INC.** agrees to deliver the **LASER COPIER PRINTER SCANNER MACHINE** in accordance with her/its Bid.
4. The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE III** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
