- In consideration for the sum of FOUR MILLION ONE HUNDRED EIGHTY-EIGHT THOUSAND SIX HUNDRED SIXTY-FIVE PESOS AND 25/100 ONLY (Php 4,188,665.25) or such other sums as may be ascertained, DIAMOND SUPPLY CHAIN SOLUTIONS CORP. agrees to deliver the Food and Non-food for Family food Packs in accordance with her/its Bid.
- 4. The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE III** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
