- Brought about by the declaration of a State of Calamity, or implementation of community quarantine or similar restrictions."



# APPROVAL OF THE CANCELLATION OF PROCUREMENT ACTIVITY: PURCHASE OF ADVOCACY MATERIALS OF NATIONAL HOUSEHOLD TARGETING SECTION (NHTS) CY 2023 – LOT A COVERED BY RFQ NO. 2023-08-134

WHEREAS, the Bids and Awards Committee received an endorsement from the Procurement Section of the Request for Deliberation dated September 6, 2023 for the Procurement Project: "PURCHASE OF ADVOCAX MATERIALS OF NATIONAL HOUSEHOLD TARGETING SECTION (NHTS) – LOT A covered by RFQ NO. 2023-08-134 and PR No. 2023-08-175 endorsed by the END-USER, NATIONAL HOUSEHOLD TARGETING SECTION (NHTS) under the POLICY AND PLANS DIVISION with an Approved Budget of the Contract for LOT A in the amount of THREE HUNDRED TEN THOUSAND FOUR HUNDRED EIGHTY SIX PESOS (P310,486.00);

WHEREAS, the BAC Secretariat facilitated the assessment of quotations and directed the End-User to submit the final design layout of items subject to procurement to complete the evaluation process;

WHEREAS, pending approval by the Committee of the Abstract of Quotation, a Memorandum from the Regional Director was released dated September 18, 2023 relative to the launch of a new visual identity applicable in all Agency collaterals, communications and marketing materials entitled 'Holding of All IEC Materials." The directive of the Regional Director provides that:

In line with this, the production of <u>all agency collaterals</u>, <u>communications and marketing materials will be put on hold</u> until the release of a final memorandum and guidelines form the Digital Marketing Services."

WHEREAS, on September 20, 2023, the End-User endorsed a copy of its advance Request for Cancellation for Lot A due to changes in the End-User requirements and item specifications. (Herein attached as ANNEX "A");

WHEREAS, on the basis of the directive of the Regional Director and the aforementioned advance copy of memo request that the <u>procurement project is no longer necessary</u>, the Bids and Awards Committee was in the consensus to CANCEL the bidding of the procurement project: "PURCHASE OF ADVOCAY MATERIALS OF NATIONAL HOUSEHOLD TARGETING SECTION (NHTS) – LOT A; proceed with the bid evaluation and corresponding issuance of the Abstract of Quotation for Lot B and direct the Secretariat to post the corresponding Notice of Cancellation to this effect;


