**A RESOLUTION DECLARING FIRST FAILURE FOR THE BIDDING OF THE PROJECT "SUPPLY AND DELIVERY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF POWERHOUSE WITH GENERATOR SET AND ELECTRICAL REWIRING FOR REGIONAL HOME FOR GIRLS (RHFG)- LOT A"**

**WHEREAS**, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project **SUPPLY AND DELIVERY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF POWERHOUSE WITH GENERATOR SET AND ELECTRICAL REWIRING FOR REGIONAL HOME FOR GIRLS (RHFG)-LOT A** with the Approved Budget for the Contract (ABC) amounting to: **Two Million Two Hundred Ninety-Seven Thousand Seven Hundred Pesos (PhP2,297,700.00)**, such project having been posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from August 10, 2023 to August 22, 2023;

**WHEREAS**, on August 23, 2023 the Bids and Awards Committee conducted the Opening of Bids whereby no prospective bidders signified their intent to participate and purchased the Bidding Document;

**WHEREAS**, Section 35 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 states that:

***"Failure of Bidding***

*35.1 The BAC shall declare the bidding a failure when;*

*a) No bids are received;*

**WHEREAS**, the Bids and Awards Committee conducted its mandatory review of the Approved Purchase Request of the procurement project including its ABC. The Committee was in the consensus to retain the Approved Budget for the Contract (ABC) but direct to the Secretariat to invite more bidders;



**WHEREFORE**, the BAC RESOLVES, as it is hereby RESOLVED, to declare the First Failure of Bidding for the project **“SUPPLY AND DELIVERY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF POWERHOUSE WITH GENERATOR SET AND ELECTRICAL REWIRING FOR REGIONAL HOME FOR GIRLS (RHFG)-LOT A”**. Consequently, the Bids & Awards Committee shall conduct a re-bidding as well as extending the invitation to more bidders.




