A RESOLUTION DECLARING FIRST FAILURE FOR THE BIDDING OF THE PROJECT "SUPPLY AND DELIVERY OF OFFICE SUPPLIES NECESSARY FOR THE MASSIVE PRINTING OF DOCUMENTS FOR THE 2023 REGISTRATION (OATH OF COMMITMENT, KATIBAYAN NG PAGPAPATUNAY, FORM 5, CV FORM, BENEFICIARIES ID's) LOT B"

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project **SUPPLY AND DELIVERY OF OFFICE SUPPLIES NECESSARY FOR THE MASSIVE PRINTING OF DOCUMENTS FOR THE 2023 REGISTRATION (OATH OF COMMITMENT, KATIBAYAN NG PAGPAPATUNAY, FORM 5, CV FORM, BENEFICIARIES ID's) LOT B**" with the Approved Budget for the Contract (ABC) amounting to: **Two Million Four Hundred Sixteen Thousand Five Hundred Eighty-Five Pesos (PhP2,416,585.00)**, such project having been posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from June 29, 2023 to July 19, 2023;

WHEREAS, in response to the said advertisements, **APEX OFFICE SUPPLIES & EQUIPMENT TRADING** and **RUBIEL GENERAL MERCHANDISE**, manifested their intent to participate in the bidding;

WHEREAS, the above-stated prospective bidders submitted their bids in accordance with the DSWD FO3 Guidelines on Electronic Bid Submission and Receipt within deadline on July 19, 2023 at 9:00 AM;

WHEREAS, upon careful review and deliberation, the Bids and Awards Committee checked all the submitted documents and ascertained if they were all present, using a non-discretionary "pass/fail" criterion which resulted to the following findings:

WHEREAS, in accordance with Section 30.1 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184, the bids of **APEX OFFICE SUPPLIES & EQUIPMENT TRADING** and **RUBIEL GENERAL MERCHANDISE** were rated “**FAILED**” prompting the Committee to discontinue the opening of the second folder – “Financial Component” in conformity with the guidelines set forth in Section 30.2 of the same law;

WHEREAS, Section 35 of the *aforecited law on FAILURE OF BIDDING* provides that;

“35.1 The BAC shall declare the bidding a Failure when:

b.) All prospective bidders are declared ineligible;”

WHEREAS, the Committee having no bids determined to have passed the bid requirements for the technical component moved to invoke Section 35.1 of the abovementioned law and thereafter proceeded with the mandatory review of the terms and conditions of the project as well as the directive to the Secretariat to prepare for the re-advertisement/bidding thereof.

Consequently, the Bids & Awards Committee shall direct the secretariat to conduct a re-bidding with re-advertisement and re-posting of the said procurement project subject to the exhaustion of remedies allowed under the law as exercised by the participating bidders and after review of the specifications and other requirements of the project subject for bidding;


