

**Contract Agreement Form for the
Procurement of Infrastructure Projects (Revised)**

[not required to be submitted with the Bid, but it shall be submitted within ten (10) days after receiving the Notice of Award]

CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of SEP 25 2023 20____ between **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – FIELD OFFICE III** of Brgy. Maimpis, City of San Fernando, Pampanga (hereinafter called the “Entity”) and **EDM CONSTRUCTION**, of 2nd Ave, Unisite, Subdivision Del Pilar City of San Fernando Pampanga, Philippines (hereinafter called the “Contractor”).

WHEREAS, the Entity is desirous that the Contractor execute the project: **SUPPLY AND DELIVERY OF LABOR AND MATERIALS FOR THE IMPROVEMENT OF PERIMETER FENCE WITH SOLAR LIGHTINGS FOR VARIOUS DSWD FIELD OFFICE III CENTERS AND FACILITIES (LOT B – HAVEN)** with Contract No. 2023-08-08 (hereinafter called “the Works”) and the Entity has accepted the Bid for **TWO MILLION THIRTY-SEVEN THOUSAND FIVE HUNDRED ONE PESOS AND 87/100 (Php 2,037,501.87)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

Philippine Bidding Documents (PBDs) with
ITB No. **GOP/DSWD3-2023-07-002**;

- i. Detail Estimate;
- ii. Cash Flow;
- iii. Program of Works
- iv. Specifications;
- v. Bill of Quantities;
- vi. General and Special Conditions of Contract;
- vii. Supplemental or Bid Bulletins - **SBB NO. 2023-07-03**

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;



Performance Security;

Notice of Award of Contract and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **TWO MILLION THIRTY-SEVEN THOUSAND FIVE HUNDRED ONE PESOS AND 87/100 (Php 2,037,501.87)** or such other sums as may be ascertained, **EDM CONSTRUCTION** agrees to **SUPPLY AND DELIVERY OF LABOR AND MATERIALS FOR THE IMPROVEMENT OF PERIMETER FENCE WITH SOLAR LIGHTINGS FOR VARIOUS DSWD FIELD OFFICE III CENTERS AND FACILITIES (LOT B – HAVEN)** in accordance with its Bid.
4. The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – FIELD OFFICE III** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






