

**Contract Agreement Form for the Procurement of Goods (Revised)**  
*[Not required to be submitted with the Bid, but it shall be submitted within ten (10) days after receiving the Notice of Award]*

**CONTRACT AGREEMENT**

THIS AGREEMENT made the \_\_\_\_ day of DEC 07 2023 20\_\_ between DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – FIELD OFFICE III of the Philippines (hereinafter called “the Entity”) of the one part and JONECO TECH MARKETING CORP. of Jomafer Bldg, Brgy, Dolores City of San Fernando, Pampanga, Philippines. (hereinafter called the “Contractor”).

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly “SUPPLY AND DELIVERY OF LAPTOPS FOR THE USE OF DSWD FO III PANTAWID PAMILYANG PILIPINO PROGRAM-CITY/MUNICIPAL LINKS” with Contract No. 2023-11-05 hereinafter called “the Works”) and has accepted the Bid by the supplier for the Supply of those Goods and Services in the sum of **TWENTY FIVE MILLION TWO HUNDRED SIXTY-SIX THOUSAND THREE HUNDRED EIGHTEEN PESOS ONLY (Php 25,266,318.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this *Agreement* words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs) with ITB No. **GOP/DSWD3-2023-10-003**;
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental Bid Bulletin; 2023-10-003
  - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and



v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **TWENTY FIVE MILLION TWO HUNDRED SIXTY-SIX THOUSAND THREE HUNDRED EIGHTEEN PESOS ONLY (Php 25,266,318.00)** or such other sums as may be ascertained, **JONECO TECH MARKETING CORP.** agrees to **"SUPPLY AND DELIVERY OF LAPTOPS FOR THE USE OF DSWD FO III PANTAWID PAMILYANG PILIPINO PROGRAM-CITY/MUNICIPAL LINKS"** in accordance with its Bid.
4. The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – FIELD OFFICE III** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
