NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz*.:
 - a. Philippine Bidding Documents (PBDs);
 - ITB No. GOP/DSWD3-2023-11-002
 - Drawings/Plans;
 - ii. Specifications;

- iii. Bill of Quantities; and
- iv. General and Special Conditions of Contract;
- **b.** Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of NINE MILLION TWO HUNDRED SEVENTY-EIGHT THOUSAND TWO HUNDRED SEVENTY-SEVEN PESOS AND 26/100 (PhP9,278,277.26) or such other sums as may be ascertained EDM CONSTRUCTION agrees to "SUPPLY AND DELIVERY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF RESIDENTIAL COTTAGE OF REGIONAL REHABILITATION CENTER FOR YOUTH (RRCY) AT MAGALANG, PAMPANGA" in accordance with its Bid.
- The DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE III agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
