60/100 (Php 1,225,888.60)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this *Agreement* words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

In consideration for the sum of **ONE MILLION TWO HUNDRED TWENTY FIVE THOUSAND EIGHT HUNDRED EIGHTY EIGHT AND 60/100 (Php 1,225,888.60)** or such other sums as may be ascertained, **MB PELAEZ SCHOOL AND OFFICE SUPPLIES** agrees to **SUPPLY AND DELIVERY OF OFFICE SUPPLIES FOR THE TWO (2) MONTH USE (FOR OCTOBER TO NOVEMBER) OF VARIOUS OFFICES OF DSWD FIELD OFFICE III FOR CY 2023 (LOT A – A4 COPY PAPER)** in accordance with its Bid.
4. The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – FIELD OFFICE III** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

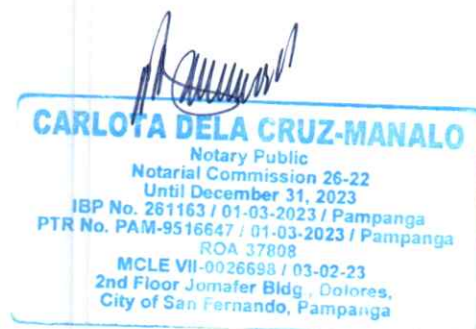



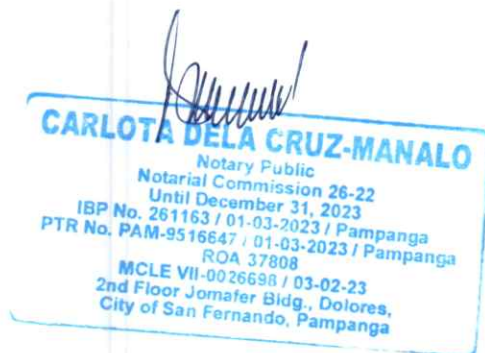
