**A RESOLUTION DECLARING FIRST FAILURE FOR  
THE BIDDING OF THE PROJECT "SUPPLY AND DELIVERY  
OF (DESKTOP AND SCANNERS) FOR DSWD FIELD OFFICE III  
REGIONAL SOCIAL PENSION UNIT (RSPU) RPMO & DPEO STAFF"**

**WHEREAS**, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project "**SUPPLY AND DELIVERY OF (DESKTOP AND SCANNERS) FOR DSWD FIELD OFFICE III REGIONAL SOCIAL PENSION UNIT (RSPU) RPMO & DPEO STAFF**" with the Approved Budget for the Contract (ABC) amounting to: **ONE MILLION NINE HUNDRED SEVENTY-THREE THOUSAND PESOS (PhP1,973,000.00)**; the Invitation to Bid having been posted in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from November 25, 2023 to December 15, 2023;

**WHEREAS**, on December 18, 2023 the Bids and Awards Committee conducted the Opening of Bids as published. However, despite diligent efforts of the Secretariat, no prospective bidders signified their intent to participate and purchased the Bidding Document;

**WHEREAS**, Section 35 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 states that:

***"Failure of Bidding***

***35.1 The BAC shall declare the bidding a failure when;***

***a) No bids are received;***

***xxx"***

**WHEREAS**, the Bids and Awards Committee in conformity with the same law conducted a mandatory review after Opening of Bids of the terms, conditions and specification to determine the reason for the failure whereby the consensus was to revert the documents to the Procurement Section for coordination with the End-User with the option of either (1) retention of the Technical Specifications of the Computer Desktop sets to ensure reliable brand offers but with reduction of the quantity of items to be purchased or (2) revisit the Approved Budget of the Contract (ABC) unless the End-User is amenable with possible generic offer/bid anchored on the

feedback on low the insufficiency of the Approved Budget of the Contract (ABC) obtained by the Secretariat from Service Providers which declined the invite;

**THEREFORE**, the Bids and Awards Committee **RESOLVES**, as it is hereby **RESOLVED**, to **DECLARE** the **FIRST FAILURE OF BIDDING** for the project **"SUPPLY AND DELIVERY OF (DESKTOP AND SCANNERS) FOR DSWD FIELD OFFICE III REGIONAL SOCIAL PENSION UNIT (RSPU) RPMO & DPEO STAFF"** and to **REVERT** the documents to the Procurement Section for coordination with the End-User with the option of either (1) retention of the Technical Specifications of the Computer Desktop sets to ensure reliable brand offers but with reduction of the quantity of items to be purchased or (2) revisit the Approved Budget of the Contract (ABC) unless the End-User is amenable with possible generic offer/bid.


