This is to reiterate the consolidated guidelines regarding the wearing of prescribed uniforms and dress code from the previous Fiscal Year (FY), as we await the finalization and procurement of the new uniform design and materials for FY 2024.

In alignment with the Memorandum issued by our Secretary on April 25, 2023, and the subsequent clarificatory memorandum dated August 18, 2023, the following directives are restated for compliance by all DSWD officials and employees, including Contract of Service (COS) and Job Order (JO) workers:

- COS and JO Workers: May follow the color-coding for Monday to Thursday with black pants/skirt or wear a WHITE formal top with a collar. They are also allowed to wear collared formal tops with printed designs/patterns, provided the dominant color matches the day's color requirement.
- Field Operations Attire: Employees in field/field operations may wear polo shirts following the color coding or the DSWD red vest, with DSWD IDs visibly worn at all times.
- Medical Personnel: Scrub suits are permitted for those working in clinics, centers, or institutions due to the nature of their work.
- □ **ID Requirement**: Proper wearing of DSWD IDs in the Department premises is mandatory at all times.

## **Prohibited Attire:**

The following attire is considered inappropriate for the workplace:

□ Spaghetti-strapped dresses, tube blouses, sleeveless tops, party dresses, tight-fitting clothing, micro-mini dresses, picnic clothes, leggings, ripped jeans, pedal pushers.

□ Open-toe footwear, sandals, and slippers.

Colorful socks, excessive costume jewelry, and heavy/theatrical make-up.

Violations of these guidelines will be addressed in accordance with DSWD Memorandum Circular (MC) No. 09, series of 2009.

The purpose of this memorandum is to ensure a uniform and professional appearance among all employees, reflecting our collective identity and dedication to service. Your cooperation and compliance with these guidelines are highly appreciated.
