<p>Section VI. Schedule of Requirements: <i>"Within THIRTY (30) calendar days from the issuance of Notice to Proceed."</i></p>	<p>The project commences upon receipt of the Notice to Proceed up to the completion of the schedule as indicated in the Terms of Specification.</p>

<p><i>PBD. Item No 20.1:</i></p> <p><i>"..Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) and other appropriate licenses and permits required by law and stated in the BDS."</i></p>	<p>The BAC will accept manually filed Income Tax returns in compliance with GPPB NPM-No. 170-2012, provided that the information submitted is accurate, up-to-date, and valid.</p>
<p><i>"Required Licenses and Affiliations of Pest Control Provider to ensure legitimacy, credibility and high standard of service..."</i></p>	<p>The BAC will not require any additional documents, licenses, or proof of affiliations beyond those specified in Section V of the posted Philippine Bidding Document for this project. Furthermore, during the bid opening, the BAC and its TWG will assess the presence or absence of the minimum requirements stipulated therein. However, prospective bidders are free to submit relevant supporting documents to</p>

	demonstrate their legitimacy, credibility, and capability to deliver the service, if they so choose.
<i>“Price Schedule under Financial Document”</i>	As discussed during the Pre-Bidding Conference on October 18, 2024, the project consists of only one lot. However, bidders are required to specify the total price per area, which will correspond to the total bid offer. Therefore, the overall bid amount will remain the basis for determining the bidder with the lowest bid.
<i>“Is it required to conduct an ocular inspection?”</i>	The conduct of an ocular inspection is not a requirement as stated in the Philippine Bidding Document (PBD). However, bidders are not prohibited from inspecting the areas if they choose to do so.
<i>“What is the Frequency of this project?”</i>	The procuring unit intends to conduct this project annually for three consecutive years, provided that funds are available for this purpose.
<i>“Is the warranty within one (1) year or after the contract is delivered?”</i>	The Philippine Bidding Document (PBD) states that the project shall be warranted for one year. Therefore, the warranty will commence the day after the completion of the Schedule of Treatment and Submission of Reports outlined in the Terms of Reference.

Pursuant to the Revised Implementing Rules and Regulations of RA 9184, the foregoing **amendments** shall form an integral part of the project’s Bidding Documents and related Contract. Further, acknowledgement and receipt of this supplemental bid bulletin shall bound the bidder/s of the terms and conditions set forth, otherwise, the nonconformity thereof may consider the bid as nonresponsive to the bidding policies. Consequently, the same may result in the disqualification and/or rejection of the concerned bidder’s Bid.

In any instance, receipt of this Supplemental Bid Bulletin by the bidders presupposed that in the course of the preparation of their respective bids, they understood and complied with the amended specifications and terms expressed herein.

Any provision inconsistent herewith is hereby amended and superseded accordingly.
