**A RESOLUTION DECLARING FIRST FAILURE FOR THE BIDDING OF THE PROJECT "SUPPLY AND DELIVERY OF GROCERY SUPPLIES FOR 6 CRCFs (AMOR, RRCY, RHFG, TLC, THFW AND HAVEN) FOR CY 2024"**

**WHEREAS**, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project "SUPPLY AND DELIVERY OF GROCERY SUPPLIES FOR 6 CRCFs (AMOR, RRCY, RHFG, TLC, THFW AND HAVEN) FOR CY 2024" with the Approved Budget for the Contract (ABC) amounting to: **TWO MILLION ONE HUNDRED SEVENTY-THREE THOUSAND NINE HUNDRED ELEVEN PESOS AND 63/100 (PhP2,173,911.63)**; such project having been posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from July 11, 2024 to July 30, 2024;

**WHEREAS**, on July 30, 2024 the Bids and Awards Committee conducted the Opening of Bids as published. However, despite the diligent efforts of the Secretariat, no prospective bidders signified their intent to participate and purchased the Bidding Documents;

**WHEREAS**, Section 35 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 states that:

**"Failure of Bidding**

35.1 The BAC shall declare the bidding a failure when;

**a) No bids are received;**

b) All prospective bidders are declared ineligible;

c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or d) The bidder with the LCRB, HRRB, SCRB or SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and this IRR.

**WHEREAS**, the Bids and Awards Committee in conformity with the same law conducted a mandatory review after Opening of Bids of the terms, conditions and specification to determine the reason for the failure whereby the consensus was to revise duration of the project from July-




December 2024 to September-December 2024 which is equivalent to two (2) tranches and distribute the allocated items of the lapsed months to the remaining four (4) months.


**WHEREFORE**, the BAC RESOLVES, as it is hereby RESOLVED, to declare the First Failure of Bidding for the project "**SUPPLY AND DELIVERY OF GROCERY SUPPLIES FOR 6 CRCFs (AMOR, RRCY, RHFG, TLC, THFW AND HAVEN) FOR CY 2024**" and to revise technical specifications of the graphics into integrated or onboard graphics and to **REVERT** the documents to the Procurement Section for coordination with End-User. Consequently, the Bids & Awards Committee shall conduct a re-bidding with re-advertisement and re-posting of the said procurement project subject to the exhaustion of remedies allowed under the law and after review of the schedule of requirement of the project subject for bidding;


