BAC RESOLUTION DECLARING FAILURE FOR THE BIDDING OF "SUPPLY AND DELIVERY OF CONSUMABLE INKS, TONERS AND CARTRIDGE FOR THE USE OF VARIOUS OFFICES OF DSWD FIELD OFFICE III FOR CY 2024 - SECOND POSTING" IN ACCORDANCE WITH SECTION 41 OF THE 2016 RA 9184 AND ITS IRR

WHEREAS, on May 2, 2024, the DSWD Field Office III, through the Bids and Awards Committee, posted an Invitation to Bid for the **"Supply and Delivery of Consumable Inks, Toners and Cartridge for the Use of Various Offices of DSWD Field Office III for CY 2024 - Second Posting"** with an Approved Budget for the Contract amounting to **Six Million Three Hundred Two Thousand One Hundred Six Pesos (Php6,302,106.00)**, was posted at the PhilGEPS website, the DSWD Field Office III website and conspicuous places in DSWD FO III;

WHEREAS, two (2) prospective bidders attended the Pre-Bidding Conference that was held on May 10, 2024 via Google Meet video conferencing namely:

1. Quartz Business Product Corporation
2. Accessories and Supplies Depot, Inc.

WHEREAS, on May 22, 2024, the Bids and Awards Committee, BAC Technical Working Group and BAC Secretariat conducted the Opening of Bids of the above-mentioned project via Google Meet video conferencing at Office of the ARDA's Conference Room and was solely attended by Quartz Business Product Corporation;

WHEREAS, Quartz Business Product Corporation was declared as **"PASSED"** using a non-discretionary "pass/fail" criterion as to the compliance on the Legal, Technical. The BAC proceeded to the opening of Financial Component Envelope of the bidder and was declared as the **Single Calculated Bid (SCB)** with a financial bid amounting to **SIX MILLION TWO HUNDRED NINETY THOUSAND AND TEN PESOS (Php6,290,010.00)**;

WHEREAS, The Technical Working Group (TWG) of Inks and Toners submitted their TWG Report recommending to proceed with the post-qualification dated May 23, 2024.

WHEREAS, on May 30, 2024, the Bids and Awards Committee together with the Technical Working Group conducted the Post Qualification in which Quartz Business Product Corporation was declared as the bidder with Single Calculated and Responsive-Bid (SCRB);

WHEREAS, the BAC Secretariat notified Quartz Business Product Corporation through email that the project was awarded to the bidder through the issuance of the Notice of Award dated June 4, 2024 and was received by them on June 10, 2024;

WHEREAS, on June 18, 2024, it was discovered that there are inconsistencies on the quantity of a specific item on the Invitation to Bid (ITB), to wit:

NOW, THEREFORE, the BAC RESOLVES, as it is hereby RESOLVED, the committee hereby approve the recommendation of the following:

- To declare a **FAILURE OF BIDDING** for the **SUPPLY AND DELIVERY OF CONSUMABLE INKS, TONERS AND CARTRIDGE FOR THE USE OF VARIOUS OFFICES OF DSWD FIELD OFFICE III FOR CY 2024 – SECOND POSTING** in accordance with Section 41 Reservation Clause of the 2016 Implementing Rules and Regulations of Republic Act No. 9184;
- To **REVOKE** the Notice of Award issued to Quartz Business Product Corporation in accordance with Section 41 of the Revised IRR of RA No. 9184; and
- To **REPOST** the **SUPPLY AND DELIVERY OF CONSUMABLE INKS, TONERS AND CARTRIDGE FOR THE USE OF VARIOUS OFFICES OF DSWD FIELD OFFICE III FOR CY 2024 – SECOND POSTING** through **COMPETITIVE BIDDING**.
