**A RESOLUTION DECLARING FIRST FAILURE FOR THE BIDDING OF THE PROJECT
"SUPPLY AND DELIVERY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF
VARIOUS BUILDING IMPROVEMENTS AND UPGRADING OF DRAINAGE ALONG
EXISTING ROADWAY RIGHT SIDE OF THE CENTER OF TARLAC HOME FOR WOMEN
FOR CY 2024"**

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project "**SUPPLY AND DELIVERY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF VARIOUS BUILDING IMPROVEMENTS AND UPGRADING OF DRAINAGE ALONG EXISTING ROADWAY RIGHT SIDE OF THE CENTER OF TARLAC HOME FOR WOMEN FOR CY 2024**" with the Approved Budget for the Contract (ABC) amounting to: ~~Two~~ Million One Hundred Five Thousand Eight Hundred Fifty-Nine Pesos and 89/100 (**PhP2,105,859.89**); such project having been posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from April 30, 2024 to May 20, 2024;

WHEREAS, on May 20, 2024 the Bids and Awards Committee conducted the Opening of Bids whereby two prospective bidders, A.C. Soliven Construction and General Merchandise and EDM Construction, signified its intent to participate and purchased the Bidding Document for Lot A and Lot B respectively, however, declared as FAILED;

WHEREAS, upon careful review and deliberation, the Bids and Awards Committee found that the documents submitted by the Service Providers resulted to the following findings:

WHEREAS, the aforementioned findings constituted the grounds for the "FAILED" rating of the submitted Technical Component Folders of the abovementioned bidder;

WHEREAS, Section 35 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 states that:

"Failure of Bidding

35.1 The BAC shall declare the bidding a failure when;

a) No bids are received; b) **All prospective bidders are declared ineligible**; c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or d) The bidder with the LCRB, HRRB, SCRB or SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and this IRR.

WHEREFORE, the BAC RESOLVES, as it is hereby RESOLVED, to declare the First Failure of Bidding for the project "SUPPLY AND DELIVERY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF VARIOUS BUILDING IMPROVEMENTS AND UPGRADING OF DRAINAGE ALONG EXISTING ROADWAY RIGHT SIDE OF THE CENTER OF TARLAC HOME FOR WOMEN FOR CY 2024". Consequently, the Bids & Awards Committee shall conduct a re-bidding with re-advertisement and re-posting of the said procurement project subject to the exhaustion of remedies allowed under the law as exercised by the participating bidders and after review of the schedule of requirement of the project subject for bidding;


