CONTRACT AGREEMENT  
No. 2024-11-0004

This Contract Agreement is made this **DEC 16 2024** by and between the **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT - FIELD OFFICE III of Bay Mampis, Cebu** (hereinafter called the Entity) and **D-THREE PEST MANAGEMENT SERVICES, INC. (D-3)** (Arriaga St. San Juan City, Metro Manila, No. 11, Mappihitech.com.ph) (hereinafter called the Contractor)

WHEREAS the Entity is desirous that the Contractor execute the project "PROCUREMENT OF SERVICE PROVIDER FOR THE TERMITE AND PEST CONTROL FOR CENTERS AND INSTITUTIONS FOR CY 2024" with Contract No. 2024-11-0004 (hereinafter called the Works) and the Entity has accepted the Bid for ONE MILLION FIVE HUNDRED EIGHTY EIGHT THOUSAND FORTY FIVE PESOS AND 18/100 (Php 1,588,045.18); by the Contractor for the execution and completion of such Works and the remedying of any defects therein

THIS CONTRACT AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
  - a. Philippine Bidding Documents (PDBs) with ITB No. GOP/DSWD3-2024-09-0005;
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract, and
    - iv. Supplemental or Bid Bulletins SBB No.2024-10-0002
  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted:  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - c. Performance Security
  - d. Notice of Award of Contract and the Bidder's conform thereto, and




c. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

2. In consideration for the sum of ONE MILLION FIVE HUNDRED EIGHTY EIGHT THOUSAND FORTY FIVE PESOS AND 18/100 (Php 1,588,045.18) or such other sums as may be ascertained, **D-THREE PEST MANAGEMENT SERVICES** agrees to **PROCUREMENT OF SERVICE PROVIDER FOR THE TERMITE AND PEST CONTROL FOR CENTERS AND INSTITUTIONS FOR CY 2024** in accordance with its Bid.
4. The **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – FIELD OFFICE III** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
