- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PDBs) with ITB NO. GOP/DSWD3-2024-09-0904;
 - i. Drawing/Plans;
 - ii. Specifications:
 - iii. Bill of Quantities:
 - iv. Contractor's Terms of Reference; and
 - v. Program of Works.
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract/ documents that may/be required by existing laws and/or the

- 4. The DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE III agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
