BAC RESOLUTION DECLARING FAILURE FOR THE BIDDING OF "PROCUREMENT OF SECONDARY INTERNET SERVICE PROVIDER OF SWAD AURORA, SWAD BATAAN AND SWAD NUEVA ECIJA CY 2024 – 2ND POSTING" IN ACCORDANCE WITH SECTION 35 OF THE 2016 RA 9184 AND ITS IRR

WHEREAS, on July 15, 2024, the DSWD Field Office III, through the Bids and Awards Committee, posted an Invitation to Bid for the "**PROCUREMENT OF SECONDARY INTERNET SERVICE PROVIDER OF SWAD AURORA, SWAD BATAAN AND SWAD NUEVA ECIJA CY 2024 – 2ND POSTING**" with an Approved Budget for the Contract amounting to **ONE MILLION SEVEN HUNDRED FIFTY-SEVEN THOUSAND SEVEN HUNDRED TWENTY-EIGHT PESOS (Php1,757,728.00)**, was posted at the PhilGEPS website, the DSWD Field Office III website and conspicuous places in DSWD FO III;

WHEREAS, on July 24, 2024, the Bids and Awards Committee, BAC Technical Working Group and BAC Secretariat conducted the Pre-Bidding Conference of the above-mentioned project via Google Meet video conferencing and was attended one (1) prospective bidder namely Innove Communications, Inc.;

WHEREAS, during the Pre-Bidding Conference, the Technical Working Group (TWG) expressed their observation on the project duration of eight (8) months in which four (4) months were already lapsed, which could affect the execution of the contract;

WHEREAS, the consensus of the Bids and Awards Committee together with the Technical Working Group was to adjust the duration of the project and the Approved Budget for the Contract (ABC) by the End-User;

WHEREAS, on July 29 2024, the End-User provided the adjusted Approved Budget for the Contract amounting to **EIGHT HUNDRED SEVENTY-EIGHT THOUSAND EIGHT HUNDRED SIXTY-FOUR PÉSOS (Php878,864.00)** for four (4) months of internet subscription in which this will be resorted to the mode of procurement of Small Value Procurement (SVP);

WHEREAS, Section 35.3 of the Revised IRR of RA No. 9184, explicitly states that there is a failure of bidding when:

Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a rebidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.;

NOW, THEREFORE, the BAC RESOLVES, as it is hereby RESOLVED, the committee hereby approve the recommendation of the following:

- To declare a **FAILURE OF BIDDING** for the **PROCUREMENT OF SECONDARY INTERNET SERVICE PROVIDER OF SWAD AURORA, SWAD BATAAN AND SWAD NUEVA ECIJA CY 2024 – 2ND POSTING** in

accordance with Section 35 Failure of Bidding of the 2016 Implementing Rules and Regulations of Republic Act No. 9184;

- To REPOST the **PROCUREMENT OF SECONDARY INTERNET SERVICE PROVIDER OF SWAD AURORA, SWAD BATAAN AND SWAD NUEVA ECIJA CY 2024 – 2ND POSTING** through **SMALL VALUE PROCUREMENT (SVP)**.
