A RESOLUTION DECLARING SECOND FAILURE FOR THE BIDDING OF THE PROJECT "PURCHASE OF RJJWC III LIVELIHOOD KITS/TOOLS FOR WELDING TO SUPPORT BAHAY PAG-ASA (BPA) PROJECT CY 2024 - 2ND POSTING"

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project "PURCHASE OF RIJWC III LIVELIHOOD KITS/TOOLS FOR WELDING TO SUPPORT BAHAY PAG-ASA (BPA) PROJECT CY 2024 -2ND POSTING" with the Approved Budget for the Contract (ABC) amounting to: 2NE MILLION WENTY-FIVE THOUSAND THREE HUNDRED THIRTY-TWO PESOS AND \$6/100 (Php1,025,332.56); such project having been posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from October 2, 2024 to October 22, 2024;

WHEREAS, on October 22, 2024 the Dids and Awards Committee conducted the Øpening of Bids as published. However, despite the diligent efforts of the Secretariat, no prospective bidders signified their intent to participate and purchased the Bidding Documents;

WHEREAS, Section 35 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 states that:

"Failure of Bidding

35.1 The BAC shall declare the bidding a failure when;

## a) No bids are received;

- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or d) The bidder with the LCRB, HRRB, SCRB or SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and this IRR.

WHEREAS, the Bids and Awards Committee in conformity with the same law conducted a mandatory review after Opening of Bids of the terms, conditions and specification to determine the reason for the second failure whereby the consensus was to retain the Terms of Reference



and Approved Budget for the Contract and revert the documents to the Procurement Section for coordination with the End-User;

WHEREAS, in accordance with Section 53.1 of the 2016 IRR of RA 9184 which provides that "Two Failed Biddings. Where there has been failure of competitive bidding or Limited Source Bidding for the second time as provided in Section 35 of the Act and this IRR", the Bids and Awards Committee found fit to recommend that this procurement project shall be subjected to "Negotiated Procurement – Two Failed Biddings" being most expedient, effective and economical modality given these circumstances:

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To declare a SECOND FAILURE OF BIDDING for the PURCHASE OF AJJWC III
  LIVELIHOOD KITS/TOOLS FOR WELDING TO SUPPORT BAHAY PAG-ASA
  (BPA) PROJECT CY 2024 2ND POSTING with the Approved Budget for the
  Contract of ONE MILLION TWENTY-FIVE THOUSAND THREE HUNDRED
  THIRTY-TWO PESOS AND 56/100 (Php1,025,332.56) in accordance with Section
  35.1 of the 2016 Implementing Rules and Regulations of Republic Act. No. 9184;
  and
- To resort to NEGOTIATED PROCUREMENT TWO FAILED BIDDINGS as provided in Section 53.1 of the revised IRR of RA 9184 and all applicable rules and regulations in accordance with law.
