WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project "PURCHASE OF DSWD ADVOCACY MATERIAL (RED VEST) FOR CRISIS INTERVENTION SECTION CY 2024" with the Approved Budget for the Contract (ABC) amounting to TWO MILLION SIX HUNDRED THOUSAND PESOS ONLY (PhP2,600,000.00); such project having been posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from November 15, 2024 to December 5, 2024;

WHEREAS, on December 5, 2024 the Bids and Awards Committee conducted the Opening of Bids whereby one prospective bidder, CYN TRADING AND SERVICES, INC., signified its intent to participate and purchased the Bidding Document, however, declared as FAILED:

WHEREAS, upon careful review and deliberation, the Bids and Awards Committee found that the documents submitted by the Service Providers resulted to the following findings:
