 "PURCHASE OF DSWD ADVOCACY MATERIAL (RED VEST) FOR CRISIS INTERVENTION

**WHEREAS**, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project "**PURCHASE OF DSWD ADVOCACY MATERIAL (RED VEST) FOR CRISIS INTERVENTION SECTION CY 2024**" with the Approved Budget for the Contract (ABC) amounting to **TWO MILLION SIX HUNDRED THOUSAND PESOS ONLY (Php2,600,000.00)**; such project having been posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from November 15, 2024 to December 5, 2024;

**WHEREAS**, on December 5, 2024 the Bids and Awards Committee conducted the Opening of Bids whereby one prospective bidder, **CYN TRADING AND SERVICES, INC.**, signified its intent to participate and purchased the Bidding Document, however, declared as **FAILED**;

**WHEREAS**, upon careful review and deliberation, the Bids and Awards Committee found that the documents submitted by the Service Providers resulted to the following findings:

**WHEREAS**, the aforementioned findings constituted the grounds for the "**FAILED**" rating of the submitted Technical Component Folders of the abovementioned bidder;

**WHEREAS**, Section 35 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 states that:

**"Failure of Bidding**

35.1 The BAC shall declare the bidding a failure when;

b) All prospective bidders are declared ineligible;

WHEREFORE, the BAC RESOLVES, as it is hereby RESOLVED, to declare the First Failure of Bidding for the project **"PURCHASE OF DSWD ADVOCACY MATERIAL (RED VEST) FOR CRISIS INTERVENTION SECTION CY 2024"** and to REVERT the documents to the Procurement Section for coordination with the End-User concerning the Technical Specifications and Approved Budget for the Contract (ABC) of the project.


