WHEREAS, Section 48 of the 2016 IRR of Republic Act No. 9184 provides that subject to the prior approval of the Head of the Procuring Entity, and whenever justified by the conditions provided in this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in this Rule;

WHEREAS, the Head of the Procuring Entity upon recommendation of the Bids and Awards Committee approved the Annual Procurement Plan (APP) CY 2024 of Field Office III encompassing the proposed mode of procurement of the End-User submitted through its pertinent Project Procurement Management Plan stating that this alternative method of procurement shall be resorted to in order to promote economy and efficiency;

WHEREAS, The Bids and Awards Committee was authorized to resort to Alternative Methods of Procurement pursuant to the provision of Section 53.9 of the 2016/IRR of Republic Act No. 9184 – Negotiated Procurement: Small Value Procurement;
