**BAC RESOLUTION DECLARING THE POST-DISQUALIFICATION OF THE SINGLE CALCULATED BIDDER AND RE-ADVERTISEMENT OF THE PROJECT "SUPPLY AND DELIVERY OF GROCERY SUPPLIES FOR 6 CRCFs (AMOR, RRCY, RHFG, TLC, THFW AND HAVEN) FOR 1<sup>ST</sup> QUARTER OF CY 2025 – 2"**ITB No. GOP/DSWD3-2025-01-0001  
(PR No. 2024-10-01, 10-031, 10-032, 10-036, 10-067 and 11-020)

**WHEREAS**, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project **"SUPPLY AND DELIVERY OF GROCERY SUPPLIES FOR 6 CRCFs (AMOR, RRCY, RHFG, TLC, THFW AND HAVEN) FOR 1<sup>ST</sup> QUARTER OF CY 2025 – 2"** with the Approved Budget for the Contract (ABC) amounting to **ONE MILLION FOUR HUNDRED THIRTEEN THOUSAND EIGHTY-FOUR PESOS ONLY (PhP1,413,084.00)**; such project having been posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from January 17, 2025 to February 5, 2025;

**WHEREAS**, on February 5, 2025 the Bids and Awards Committee conducted the Opening of Bids whereby one prospective bidder, **PROVIDERS MULTI-PURPOSE COOPERATIVE**, signified its intent to participate and purchased the Bidding Document;

**WHEREAS**, during the preliminary examination of bid, **PROVIDERS MULTI-PURPOSE COOPERATIVE** was declared as the **SINGLE CALCULATED BID (SCB)** with a bid amount of **ONE MILLION THREE HUNDRED SEVENTY-TWO THOUSAND SEVENTY-SEVEN PESOS AND 62/100 (PHP 1,372,077.62)** based on the presence of the submitted documents;

**WHEREAS**, on February 6, 2025, the Technical Working Group conducted a detailed bid evaluation of the abovementioned bids as to completeness of the submitted bids and conformity with the technical specifications;

**WHEREAS**, during the Post Qualification on February 12, 2025, upon careful validation of the eligibility, technical and financial documents submitted by the Single Calculated Bidder, **PROVIDERS MULTI-PURPOSE COOPERATIVE**, its bid was found non-responsive and post-disqualified due to the inconsistent technical specifications and sample evidence provided on the following item:

**WHEREAS**, Section 35 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 states that:

***"Failure of Bidding"***

35.1 The BAC shall declare the bidding a failure when;

b) All prospective bidders are declared ineligible

xxx"

**WHEREAS**, the Bids and Awards Committee in conformity with Section 35.2 and Section 35.3 of the same law conducted a mandatory review following the Post Qualification process to assess to the terms, conditions and specification to determine the reason for the second failure of bidding whereby the consensus was to revise the period coverage in the title of the project from first quarter to second quarter, update the Schedule of Requirements, evaluate the Approved Budget for the Contract to determine necessary adjustments due to price fluctuations, reflect all revisions on the Terms of Reference and revert the documents to the Procurement Section for coordination with the End-User;

**WHEREAS**, in accordance with Section 53.1 of the 2016 IRR of RA 9184 which provides that "Two Failed Biddings. Where there has been failure of competitive bidding or Limited Source Bidding for the second time as provided in Section 35 of the Act and this IRR", the Bids and Awards Committee found fit to recommend that this procurement project shall be subjected to "Negotiated Procurement – Two Failed Biddings" being most expedient, effective and economical modality given these circumstances;

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. To declare **PROVIDERS MULTI-PURPOSE COOPERATIVE** non-responsive and post-disqualified due to the aforementioned grounds;
2. To revise the Title, Terms of Reference, Schedule of Requirements and evaluate the Approved Budget for the Contract (ABC);
3. To declare a **SECOND FAILURE OF BIDDING** for the **SUPPLY AND DELIVERY OF GROCERY SUPPLIES FOR 6 CRCFs (AMOR, RRCY, RHFG, TLC, THFW AND HAVEN) FOR 1ST QUARTER OF CY 2025 – 2** with the Approved Budget for the Contract of **ONE MILLION FOUR HUNDRED THIRTEEN THOUSAND EIGHTY-FOUR PESOS ONLY (PhP1,413,084.00)** in accordance with Section 35 of the 2016 Implementing Rules and Regulations of Republic Act. No. 9184; and
4. To resort to **NEGOTIATED PROCUREMENT** **TWO FAILED BIDDINGS** as provided in Section 53.1 of the revised IRR of RA 9184 and all applicable rules and regulations in accordance with law.




