A RESOLUTION DECLARING FIRST FAILURE FOR THE BIDDING OF THE PROJECT "SUPPLY AND DELIVERY OF CENTRALIZED OFFICE SUPPLIES AND CONSUMABLES FOR CY 2025 - B"

WHEREAS, the Department of Social Welfare and Development Field Office III Bids and Awards Committee advertised the project "SUPPLY AND DELIVERY OF CENTRALIZED OFFICE SUPPLIES AND CONSUMABLES FOR CY 2025 - B" with the Approved Budget for the Contract (ABC) amounting to: Eight Million Nine Hundred Eighty-Eight Thousand Two Hundred Fifty-One Pesos and 60/100 (PhP8,988,251.60); such project having been posted for an Invitation to Bid in the DSWD FO III website, PhilGEPS and conspicuous places at the premises of the Department of Social Welfare and Development Field Office III continuously from April 14, 2025 to May 6, 2025;

WHEREAS, on May 6, 2025 the Bids and Awards Committee conducted the Opening of Bids whereby no bidder signified its intent to participate and purchased the Bidding Document;

WHEREAS, Section 35 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 states that:

"Failure of Bidding

35.1 The BAC shall declare the bidding a failure when;

a) No bids are received; b) All prospective bidders are declared ineligible; c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or d) The bidder with the LCRB, HRRB, SCRB or SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and this IRR.

WHEREAS, the Bids and Awards Committee conducted its mandatory review of the procurement project. The Committee was in the consensus to retain the ABC finding it's resonate and revert the documents to Procurement Planning Management Unit (PPMU) for further assessment of the documents.
